## Introduction

EIT Health represents a unique Network++ of complementary partners, who proactively combine and apply their assets and strengths (along common interests) to identify and close competence gaps, to connect with major innovation hubs (within and outside of the EU), to share best practices, and to scale up proven concepts on the European level.

As presented in [EIT Health's Strategic Agenda 2021-2027](#), EIT Health developed a strong portfolio of educational offerings in the past, and those achievements continue to inform our Education Portfolio 2.0. Currently in its first years of implementation, EIT Health's Education Portfolio 2.0 aims at educating 30,000 change-agents to scale sustainable and systemic solutions to strengthening healthcare systems.

To achieve this, Education Portfolio 2.0. offers two learning pathways to talents, one on Entrepreneurship Education and the other one designed to enhance professionals' development, with selected education and training activities collected under a lifelong learning vision for healthcare transformation. Each of the pathways establishes learning tracks that contribute to visualising the process that learners follow. In the case of the Entrepreneurship Education pathway, tracks advance progressively, starting with the adoption of entrepreneurship and innovation competences and skills and moving towards the catalysation of entrepreneurial intentions in business creation.

This Call is for activities of the Students Education & Fellowships Track, which covers both non-formal education addressed to higher education students and students who will be enrolled in the planned EIT labelled Fellowship programme. For Innovation Days (i-Days), the goal is to continue scaling the i-Days network's success in European cities, while for Continuing Summer Schools, the goal is to complete the funding cycle of an existing Summer School, and for it to become self-sustaining after that. In 2022, there will be a call for a new generation of EIT Health Summer Schools to become part of the Education Portfolio 2.0.

While it is informed by previous experience, the current Call also reinforces several important aspects that are mentioned in [EIT Health's Strategic Agenda 2021-2027](#):

- a) Education Portfolio 2.0 places more emphasis on impact and outcomes measurement. Therefore, in collaboration with EIT Health, more longitudinal data from the learners will be collected throughout the years and/or in a retrospective fashion.
- b) The activities will be aligned clearly to EIT Health goals, as well as our contribution to related UN Sustainable Development Goals (SDG), particularly SDG3, pertaining to "Good Health and Well-being", and all its targets from 3.1. to 3.9. Of special interest will be those SDG targets to which EIT Health most actively contributes (SDG 3.4 and SDG 3.8). - c) EIT Health closely connects with EU policies on education in several fields (ie. Erasmus+, digitalisation of education, entrepreneurship, etc). The present Call

connects with the [EIT HEI Initiative](#), of which EIT Health is an active member together with all EIT KICs (Knowledge Innovation Communities). The Initiative sets the basis to commence practise within the [Entrepreneurship Competences framework EntreComp](#) and to use [EPIC](#) as a measurement tool for EIT Health's Entrepreneurship Education.

- d) In order to converge activities of the entire EIT Health portfolio from a knowledge triangle perspective, and to contribute to the continuation of the students towards the next tracks of the pathway, the activities related to the Call will connect students within the EIT Health Mentoring & Coaching Network ([Mentoring & Coaching Network - EIT Health](#)).

## Call for Students Education: Delivery of Innovation Days (WP2, i-Days) and Continuing Summer School

### **Innovation Days (i-Days)**

EIT Health is calling for hosts for its [Innovation Days \(i-Days\)](#), which are challenge-based learning events that train participants in innovation and entrepreneurship, design thinking methods and pitching. The events aim to inspire creativity and collaboration while encouraging a new generation of health innovators.

i-Days target all undergraduate and postgraduate students with an interest in healthcare innovation. Participation does not require any prerequisite skills or prior experience in innovation, entrepreneurship or healthcare, making the event highly accessible.

i-Days are hosted as individual local events at various sites across Europe. They are supported by a consortium of host organisations that collaborate throughout the planning, execution and post-event phases. The final Winners' Event unites the winners and participants of all the i-Days. All winning teams will be invited to the Winners' Ceremony and the three final winning teams will receive a voucher for personalised sessions with experts from the Mentoring & Coaching Network.

EIT Health invites institutions to continue or to start hosting i-Days in close collaboration with EIT Health as the umbrella organisation for the resulting network of i-Days. The existing i-Days cities [can be consulted here](#). A dedicated Education Lead, in collaboration with an Academic & Educational Lead (WP 1), will support, develop, and enhance the organisation of these educational events, addressing the methodological perspective, overall coordination and measurement of impact to enable further strengthening of the activity.

EIT Health is also inviting those i-Days cities that have received funds for four years to submit their interest in continued membership in the i-Days network, through the ReCognition Scheme (ReCog), which is to be announced during the second quarter of 2022. These self-

sustainable i-Days are invited to leave their details [in this form](#), in order to be informed once the above-mentioned programme is launched next year.

EIT Health encourages HEI initiative consortium members to apply to run their own i-Days, and we give special emphasis to cities where EIT Health has not funded these events previously. The list of already awarded cities [can be found here](#). EIT Health also encourages professors and staff trained within the HEI activities to participate in other hosts' i-Days, to benefit from hands-on learning. This additional participation can be actively described and reported both at the proposal stage and the reporting period.

Those applying to host i-Days shall present a sustainability vision and explain how they expect to continue running once EIT Health funding ceases. The maximum duration of EIT Health funding is four years. Letters of commitment and interest from the involved stakeholders or Higher Education hierarchy are strongly encouraged.

### Continuing Summer Schools

EIT Health Summer Schools are two-to-three-week programmes delivering the knowledge, skills and attitude for creativity, innovation and entrepreneurship in fields relevant to EIT Health. Alumni from these programmes are encouraged to continue their entrepreneurial journey in EIT Health programmes matched to their stage of development, such as [Accelerator Bootcamps](#).

EIT Health is calling for Summer Schools that were previously funded in Business Plan 2020 and Business Plan 2021 and that aim to complete their funding cycle with a third and final year of funding. The Summer School must have reached or exceeded KPIs in past editions of the programme to be considered. In 2022, there will be a call for a new generation of EIT Health Summer Schools to become part of the Education Portfolio 2.0.

Successful and self-sustainable Summer Schools, including those currently applying to this Call, will be invited to apply to be part of EIT Health Recognition Scheme (ReCog Scheme) once they complete the funding cycle. The summer school currently eligible for this Call is: 210628: Energising Global Health Innovation and Entrepreneurship ([ENERGHY](#)).

## Process summary

### Proposal preparation, submission, and selection process

All activity proposals must be completed and submitted via [Plaza](#), the EIT Health submission system, which can also be reached via [BP 2022 Call page on Connections](#), the EIT Health

Community platform. Proposals follow a 2-step process: an Expression Of Interest (EOI) must first be submitted before a complete activity proposal can be submitted. The Plaza submission system will be available as of 15 December 2021.

All proposals must be formally submitted prior to the submission deadline. Applicants will need to register in Plaza well in time before the submission date. Please allow for two working days for the processing of your Plaza registration. Registration to EIT Health Plaza is done [by following this link](#). See a guide to register to Plaza [here](#).

The Education Team will be offering a webinar session with useful information for applicants:

No prior registration is required for participating in the webinars. The recordings and slides of the webinars will be made available on the dedicated working group on Connections. The activity leader of a proposal is responsible to obtain commitment from the consortium participating in the proposal before submission. The activity leader remains the single point of contact for official communication throughout the submission and review process and is responsible for the subsequent tasks that may ensue.

The submission of each proposal will follow a two-step-approach:

- Submission of an Expression of Interest (EOI): activity leaders must submit an EOI on the Plaza submission system by 18 January 2022, 16:00 CET the latest. EOIs are reviewed by the respective regional Innovation Hub office on the basis of a proposal's fit. Regional Innovation Hub offices communicate to activity Leaders, no later than 25 January 2022 to recommend whether a complete proposal should be submitted.
- Submission of Complete Proposal: activity leaders submit a complete proposal on the Plaza submission system using the same ID number from their EOI by 18 February 2022, 16:00 CET. The complete proposal form in Plaza will open on 17 January 2022 and is an extension of the EOI, information from your EOI remains available and editable in the complete proposal form. Eligibility results will be communicated to activity Leaders around 28 February 2021 no later than 2 weeks after submission.

All eligible proposals will be evaluated according to the selection criteria described in the table above.

The evaluation process involves the following stages:

#### *Remote Evaluations*

Each eligible proposal is evaluated by external evaluators based on the criteria described in the relevant between 1-15 March 2022. Evaluators are instructed to check for conflict of interest

and to inform the EIT Health Headquarters, if necessary, before evaluation of the proposal proceeds.

A maximum of 100 points will be awarded by each evaluator during the remote evaluation. The final remote evaluation score will be the average of all remote evaluators' scores.

Upon the evaluation by the Ethical, Legal and Social Implications (ELSI) board, the results will be discussed within the evaluators in a consensus meeting. The present call does not require Hearing's sessions. The final list of selected i-Days and continuing Summer School will be presented to the EIT Health Supervisory Board for approval.

The maximum total EIT contribution for an EIT Health Associate Partner is €350,000/year; for an External Project Partner this is €50,000 per year. These limits will be enforced at the selection stage.

### **Communication to applicants**

The activity leaders of all proposals will be informed about the result of their proposal, in writing, by 7 April 2022. This communication will include proposal scores and detailed evaluation feedback.

### **Confidentiality and conflict of interest**

All proposals submitted through EIT Health Plaza are accessible only to EIT Health staff members, for the processing of the application, and the Main Contact of each partner as well as the persons designated during the proposal phase. During the selection process, proposals are shared with the assigned external evaluators, who are bound to confidentiality by contract. Furthermore, EIT Health may give access to the submitted data to sub-contractors who are tasked with maintaining the Plaza system. These third parties are also bound by confidentiality provisions.

The EIT Health staff is bound by the policy on conflicts of interest.

Staff of partners of EIT Health are not involved in the evaluation process. Furthermore, members of the EIT Health Supervisory Board cannot be involved in projects.

### **Grounds for appeal and appeal procedure**

Applicants may appeal the process for the selection of their own proposal(s).

The only grounds for appeal are:

- Process errors.
- Technical problems beyond the control of applicants (e.g. the technical failure of the electronic submission system).
- Human/technical errors made by EIT Health staff.

What does not constitute grounds for appeal:



- Scores awarded in the course of the evaluation process.

Appeal process:

- Partners should send their appeals in writing to the EIT Health Management Board at [appeals@eithealth.eu](mailto:appeals@eithealth.eu) (addressing the CEO) as soon as they identify an error, but no later than 21 days after the error occurred.
- EIT Health staff at the HQ assess the claim and deliver a first response with the regional Innovation Hub/InnoStars in copy.
- If there are grounds for appeal, the staff will attempt to remedy the consequences (e.g. if a technical error of EIT Health prevented the submission of a proposal, a late submission may still be accepted as eligible).
- The EIT Health Supervisory Board is notified about the matter if:
  - o the partner does not accept that the Management Board rejects the appeal, or;
  - o there are grounds for appeal, but the problem cannot be remedied any more without disrupting the process.
