How is the programme




The Open Innovation programme is a **challenge-driven** programme.

A medical center and an industry skateholder coming together with a common challenge to pave the way for sucessful innovation adoption, for improving patient outcomes, reducing healthcare costs, working towards new models to deliver healthcare based on value.

Together with an acceleration programme for startups to fast-track the implementation and procurement of transforming health solutions across European Healthcare Providers.







Medical centres and corporate partners from the **same region** tandem with a **common unmet need**.

3 challenges will be co-defined with EIT Health from expressed unmet needs.

Selection of **10 solutions for each challenge** offered by startups from the extended network of EIT Health.

Individual mentoring and lectures provided to startups to refine **value proposition and business case** towards the challenges by clinical experts, corporate, patients, entrepreneurs and investors.

Selection of the **winning startups** during a pitch event in front of challenge promoters and investors.

EIT Health engagement on the side of promoters and startups towards **pilots**, **procurements** or any form of follow up actions.

How is the Open Innovation Programme financed?

The Open Innovation programme is **financed by EIT Health in Phase 1** as a de-risk mechanism and by the sponsor of the pilot in Phase 2.

Although Phase 1 includes a collaborative process with the *in-kind* contribution by all promoters. A partial sustainability mechanism is foreseen in case a successful event for the innovators happens due to the course of the programme and the selection pitch in front of investors.

Particularities and % of fees and distribution amongst promoters, will be discussed on a case-by-case basis and will be part of the **Promoter's agreements** and **Participants agreements** (signed by the promoters and innovators before participating in the programme).





What is the difference from previous Open Innovation **Programs?**

The main difference lies in:

- Inclusion in the promoters team, healthcare providers/healthcare systems to identified unmet need, co-define the challenge with industry and EITHealth. and scout and accelerate innovation solutions to address the challenge.
- Including the follow-up activities: piloting the solution, increasing the level of evidence, • adaptation the solution to the hospital premises, or health system inquiries, etc...
- Initial agreements in place •

What will applicants as promoters need to submit?

Tandem (partners 1 and 2) fill a common application form:

- The need and the problem description
- Why now desired TRL, technology in the market, organizational needs
- Impact Number of patients affected, QoL, etc..
- Involvement and commitment in the programme departments, key people, etc...
- Explain the collaboration between partners, if it exists already.
- ✓ Accept participation contribution
- ✓ Sign promoters agreement
- ✓ Participating experts will be required to sign an NDA to ensure free exchange of information between participants, mentors & judges/evaluators.

How will be the evaluation process look like?

The evaluation process will take place between 19th and 31st of May.

3 promoter tandems will be selected, each one in a different region.

Final selection is done by the EIT Health Executive Management Team based on the following criteria:

- Overall alignment with EIT Health Strategic Agenda.
- Overall portfolio balance.
- The overall budget available, and the approved distribution of the anticipated EIT budget across the portfolio, as approved by the EIT Health Supervisory Board.
